








FTIR


- Fourier-transform Infrared Spectroscopy
- Puts infrared light through the sample
- Measures the way the light bounces
- Checks this against a database of known substances



MDMA Pill Strength Measurements



UV-Vis Spectrophotometry quantifies a solution of MDMA based on its absorption of ultra violet light





Mass Loss Analysis separates soluble MDMA from insoluble binder and calculates the mass of MDMA that was present



Reagent Testing

Reagents are reactive chemicals which produce colour changes when reacting with other compounds.

- Fillers do not give a colour change
- Active compounds do
- No need for reference sample to see there is something
- Highly sensitive





Fentanyl Test strips


Used when:

- The sample is suspected to be an opioid
- Testing indicated the sample contains an opioid
- The user suspects the sample is contaminated with an opioid
- The user intends to inject the sample
- One Line = Positive
- Two lines = Negative
- One strong and one weak line = Negative
- The top line is the control line. Repeat if it doesn't show

A 22-year-old Brisbane rugby player has been identified as the victim of a deadly pill at Lost Paradise music festival.

Friends and family of Josh Tam took to social media in tribute of the young man's life, with one describing him as "my little mate".

He was taken to Gosford Hospital from Lost Paradise at Glenworth Valley about 8pm on Saturday, but died a short time later.

Coroner's report recommends drug policy overhaul in NSW

The report has recommended trialling pill testing and stopping the use of sniffer dogs and strip searches at music festivals in the state.



The NSW Coroner's report report has recommended implementation of pill testing at music festivals in the state, as well as a reduction in punitive policing measures.

"The faces of these young people will remain with me going forward, along with the hope that improvements will be made", Deputy State Coroner Harriet Grahame told the New South Wales Coroners Court when handing down the findings of her report.

This time last year, Julie Tam was surrounded by hundreds of mourners grieving the shock death of her 22-year-old son after he took an "unknown substance" at a music festival.

On Saturday, she was surrounded by people working to prevent more young revellers like Joshua Tam dying from taking drugs they knew hardly anything about.





Drug Checking in Australia

The ACT remains the only jurisdiction to allow drug checking

Two festivals have conducted drug checking in 2018 and 2019

Independent external evaluation was very positive

Fixed site trial commenced in August 2022 with another external evaluation underway



Can**TEST** Tested **98** samples in its second month.



Community News

CanTEST staff provided 140 health and AOD brief interventions to people who attended and 16 samples were discarded.

Heroin tested shows a wide range of purity - exercise caution when using especially from different sources.

Ketamine testing showed highly variable results with K found in less than half the samples.

Previous months' data can be found on our social media and on our website.









Ketamine

was expected in 14 samples and detected in 6

Purities ranged from 65 - 75%

1 sample contained procaine.

When Ketamine wasn't found, 4 samples contained the new psychoactive substance

2'-fluoro-2-oxo-PCE (2F-NENDCK)

an emerging research chemical with unstudied and unknown effects. Users of K are highly encouraged to test their supply and exercise high



was expected in 34 samples and

Samples tested & their purity ranges consisted of:

5/6 capsules contained 36 - 78% 10/12 powders contained 5 - 82% 9/9 pills contained <5 - 23% 6/7 crystalline contained 20 - 81%

2 pills also contained caffeine, 1 pill contained both caffeine &

methamphetamine, 1 powder also contained dimethylpentylone.

1 sample expected to be MDA instead contained MDMA (58%).



Cocaine

was expected in 14 samples and detected in 13

Purity ranged from <5 - 71%

One sample which contained no cocaine, was found to contain methamphetamine.



Heroin

was expected in 3 samples and detected in all 3

Purities ranged from 27 - 71%

identified in any samples tested.



Methamphetamine

was expected in 3 samples and detected in all 3

Purities ranged from 60 - 69%



Other Findings

A range of other expected drugs were detected, including the psychedelic 2C-B (2),

4-acetoxydimethyltryptamine and morphine.

2 found/unknown samples were presented, of which 1 was identified as methamphetamine.

25 samples were tested for the presence of fentanyl and all returned a negative result.

The new ketamine derivative 2'-fluoro-2-oxo-PCE (2F-NENDCK) was identified in 4 samples that were expected to be ketamine.

The cathinone stimulant

dimethylpentylone was identified as a major component in 1 sample that was expected to be MDMA.

Queensland is quietly looking into the use of pill-testing services as part of a harm reduction approach to drug safety in the state.

Police say the work, being led by Queensland Health but including other state government agencies, is focused on the "suitability" of the approach as part of a broader suite of measures.



Advocacy groups have called for a revisiting of the harm-reduction policies as large events like music festivals return from pandemic-related lulls.


Canberra's biggest music festival, Groovin the Moo, will not provide a testing service for illicit drugs anymore after insurers backed out only a few days before the event.

Groovin the Moo is the first event in Australia that provides free pill testing, supported by the event organisers and the ACT government, for festival-goers to check whether their drugs contain dangerous substances without getting in trouble with the law.


